1. Call to order – President Pat Grayston

President Grayston called the meeting to order at 6:07 p.m.

The following attendees were also recognized: Past President Reggie Newkirk, from the Ministry of Parks, Culture and Sport; Deputy Minister Lin Gallagher (who was present earlier), Assistant Deputy Minister Scott Brown, and Elizabeth Verrall, and from the auditing firm of MNP, Jamie Burrows.

Members were reminded that the voting members, as represented by their designated representatives, constitute a quorum for regular business as part of the Annual General Meeting and a simple majority carries the vote. At the time the meeting was called to order 42 voting members had picked up their voting cards, so a simple majority was 23. Non-voting members present were invited to speak but only voting members can make a motion.

2. Approval of the Agenda

President Grayston explained that this year, for the first time, the call for nominations from the floor was moved to the earlier sessions of the day leading up to the AGM, with the final call taking place just prior to the start of the AGM. Therefore, the first item on the agenda is a motion to cease nominations.

4. President's Report – Pat Grayston

President Grayston's formal report is included in the SaskCulture 2015-16 Annual Report, Year in Review.

President Grayston spoke about her appreciation for, and the enjoyment she gets, being around people who breathe culture. Since she was elected as President, two years ago, her definition of culture has expanded through visits around the province. She thanked the membership for sharing their enthusiasm and knowledge and for working so hard to continue and to improve cultural opportunities in Saskatchewan.

P. Grayston explained that being on the Board of SaskCulture comes with a big responsibility. The discussions the Board has, and decisions the Board makes, can impact how the members run their organizations and that the Board does not take that responsibility lightly. A lot of time is spent reading background material and if it is felt that any information is lacking to make a decision, the Board asks for more input.

She noted that Board members enjoy going around the province and attending member events. She explained how the Board shares their experiences at board meetings and become excited about supporting those doing the work with the people who are participating in culture.

P. Grayston thanked the dedicated, helpful and positive staff of SaskCulture and recognized the dedication of the Board of Directors. As President she values the friendships she has made and respects how the Board has engaged in some great debates that respectfully consider and discuss everyone's opinion until a consensus is reached no matter how long it takes.

5. General Manager's Report – Rose Gilks

General Manager Rose Gilks' formal report is included in the SaskCulture 2015-16 Annual Report, Year in Review.

Last year R. Gilks talked about the strength and commitment of the various volunteer board members she has had the privilege of working with over the years and she thanked the voting members for electing such great individuals.

This year she thanked the many knowledgeable, committed and passionate people, past and present, which have worked for SaskCulture over the past number of years as her success, as a General Manager, hinges on the ability to work within the resources available and to use those resources to surround herself with people that do great work.

Over the past ten years SaskCulture has worked diligently at becoming more diverse as a staff. When R. Gilks first started, 18 years ago, SaskCulture employed seven women between the ages of 35 and 50, so it has come a long way in terms of age, gender and ethnicity. She explained having a strong and healthy staff team is very important for a senior manager. At SaskCulture ensuring that the staff team has the diversity and range to cover SaskCulture's mandate is an ongoing challenge and the SaskCulture Board has recognized that and made a commitment to support it.

R. Gilks asked the current staff to stand and recognized them for their work. She described how, at SaskCulture, the Board of Directors and staff work closely together – each with well-defined roles – and how every four years the Board members of the day, Past Presidents, and full staff team come together to review the work of the past and set the future direction. Having the entire staff team participate in the planning process gives every member of the team an understanding and buy-in to the strategic plan.

SaskCulture's current plan has been in place for a year now. The Annual Report, *Year in Review*, is a testament to the progress that has been made on the plan and provides evidence for what's been done within the three main strategic directions:

- 1. Get more boots on the ground;
- 2. Improve access through inclusivity; and
- 3. Nurture learning and innovation.

R. Gilks went on to say that SaskCulture's role as manager for the Culture Section of Saskatchewan Lotteries Trust Fund for Sport Culture and Recreation is also laid out in the Annual Report from page 25 to 35. This section provides a fairly clear picture of where the money goes, SaskCulture's role in the management of the Culture Section of the Trust and provides a number of pie charts to demonstrate the allocation of dollars graphically. The final pages include the listing of grants by each grant program.

As for lottery revenue, for the year just ended (2015), the Trust had record sales but for the previous year (2014) sales were lower than budgeted. The current year, now three months in, is down about 15% than budgeted. Hence why it's so beneficial to be in a position to pre-fund by a year.

In conclusion, R. Gilks spoke about the changes in senior management at Sask Sport and the valuable work they do managing the Western Canadian Lottery Corporation in Saskatchewan. Sask Sport's General Manager, Jim Burnet, and Assistant General Manager, Paul Barnaby, have both retired after 30 years, which will be a big change as they have built the strong system it is today that we all benefit from.

R. Gilks encouraged the SaskCulture membership to give a motion of thanks to J. Burnet and P. Barnaby.

6. Auditor's Report and Financial Statements

Director Joanne McDonald, Chair of SaskCulture's Audit Committee, explained that SaskCulture implemented some changes to the AGM proceedings in 2016. The SaskCulture membership was provided with the analysis of the Audited Financial Statements (AFS) in writing in advance of the meeting. That document accompanied the Annual Report, which was sent to members on May 27, 2016. This change was implemented for two reasons:

- 1. To provide the membership with the detail regarding the AFS in advance of the meeting; and
- 2. To move the AGM along more quickly.

The Annual Report also contains a summarized version of the AFS.
