1. Call to order – Chair Jan Seibel

Chair Jan Seibel called the meeting to order at 4:11 p.m.

The Chair welcomed everyone and acknowledged that everyone gathered is on the traditional territories of the Cree, Saulteaux, Dene, Dakota, Nakota, Lakota First Nations and the homeland of the Métis. SaskCulture affirms that we are all Treaty people with a responsibility to uphold and honour the Treaties, our relationships to each other and the land, and to do our best – individually and collectively - to move forward in the spirit of truth and reconciliation.

The following attendees were also recognized: Past Presidents Peter England and Ann Kipling; from SPRA, Todd Shaffer; from the Ministry of Parks, Culture and Sport, Jennifer Baillargeon; from the auditing firm of MNP, Jamie Burrows; and from SK Arts, Michael Jones – a special congratulations was given to Michael on his retirement as CEO of SK Arts. Michael served nine years in the role.

Members were reminded that the voting members, as represented by their designated representatives, constitute a quorum for regular business of the Annual General meeting while amendments to the Bylaws/Constitution require a two-thirds majority of the Voting members in attendance. At the time the meeting was called to order 29 voting members had picked up their voting cards or signed in online; therefore a simple majority is 15 and a two-thirds majority is 20.

James thanked all candidates for letting their names stand and a special thanks to the Nominations Committee: Board member Heather Cline, and Em Ironstar, Saskatchewan Arts Alliance, and Yordanos Tesfamariam, Multicultural Council of Saskatchewan.

6. Chair's Report – Jan Seibel

The Chair's formal report is included in the SaskCulture 2023-24 Annual Report, Year in Review.

Jan recognized that the past year had been exciting and challenging. More people have returned to the cultural activities they enjoy and there has been an increase in applications for assistance. But there are also some organizations and events that continue to struggle due to the lingering effects of the pandemic. However, the community has rallied together to engage audiences and

participants and to remind everyone how cultural activity helps us thrive and survive. In the last few months it has been evident through record attendance at some events that there is a thirst for cultural activity and SaskCulture is here to help cultivate that.

Jan noted one of the more significant events of the past year was the renewal of the lottery license agreement for the next six years. This ensures that sport, culture and recreational activities will continue to benefit from Sask Lotteries proceeds. Jan thanked the SaskCulture staff, the partners at Sask Sport and Saskatchewan Parks and Recreation Association, and the Ministry of Parks, Culture and Sport for their hard work to ensure this agreement was renewed. It is an incredible achievement. Jan encouraged everyone to continue to buy lottery tickets to support the system.

In closing Jan gave a special thanks to all the board members, those exiting and those joining, and the CEO, Dean Kush. She is pleased to continue as Past Chair on the board for the next two years.

7. CEO's Report – Dean Kush

The Chair's formal report is included in the SaskCulture 2023-24 Annual Report, Year in Review.

Dean thanked the members for attending and recognized all the volunteers involved in the community. Volunteers are a key part of the sector. Everything they do makes a difference and has an impact. Dean also thanked the board. One of the great parts of his job is working with a board that he does not have to convince that the work being done, such as TRC and IDEA, is important. He thanked the board for their support.

Dean acknowledged the staff at SaskCulture and expressed how positive and passionate they are and how they help him stay motivated. He noted that this will be Diane Ell's last AGM as she will be retiring in March after 25 years with SaskCulture. He also congratulated staff members Elizabeth Akinyemi and Abiodun Oyelami on their upcoming wedding.

Finally, he recognized SaskCulture's global partners and the Ministry of Parks, Culture and Sport on their work to renew the lottery license agreement early.

8. Amendment to the SaskCulture Constitution and Bylaws

In recognition of the many roles non-profit corporations play in the province, the Government of Saskatchewan introduced The Non-profit Corporations Act, 2022 (the "New Act") to replace The Non-profit Corporations Act, 1995. The New Act came into force on March 12, 2023.

There were a number of changes to the Act but one in particular affects SaskCulture's Constitution. Item #26, as shown on the document that was included in the AGM package, must be updated to be in compliance with new legislation.

9. Auditor's Report and Financial Statements

The Audited Financial Statements and a written analysis of the financial statements were emailed to the membership on May 30th, or 15 days in advance of the annual meeting. The information was also posted on the website along with the Annual Report. The analysis is prepared in support of the statements for two reasons:

- 1) to provide the membership with the detail regarding the Financial Statements in advance of the meeting; and
- 2) to move the AGM along more quickly.

The Annual Report also contains a summarized version of the AFS.

A member requested that when there are changes to the The Non-profit Corporations Act, that may impact the constitution and/or bylaws of any non-profit, that SaskCulture inform the full membership to ensure compliance.

A member inquired if the new Crown Corporation, Lotteries and Gaming Saskatchewan (LGS), will have any implications for the relationship between Sask Sport, SaskCulture, Saskatchewan Parks and Recreation Association and the Ministry of Parks, Culture and Sport. LGS will monitor all regulatory portions of gaming in Saskatchewan, including lotteries. The distribution, impact measurement, and license agreement will stay with the Ministry of Parks, Culture and Sport (PCS). There is no reason to believe that LGS will attempt to combine lottery revenues into the Governments General Revenue Fund

Jan thanked the outgoing board members for their contribution and for all that they have done on behalf of the cultural community in Saskatchewan.
